1. The Blue Ridge Mountains Arts Association (hereinafter called the Gallery will provide the following: E- mailing of invitations, and publicity in newsletter and website.
2. Upon delivery, artwork should be exhibit-ready (each hanging piece should be labeled on back with name of artist, title, medium and price).
3. The Gallery reserves the right not to display every piece submitted.
4. All work must remain on exhibit for the duration of the exhibition.
5. Only original work will be accepted.
6. The Gallery will make the final determination in the display arrangement of artwork.
7. Unless notified otherwise in writing, the gallery assumes that permission is granted to photograph works for publicity, catalog, or educational purposes.
8. In the event of sales during the exhibit, the artist will receive 65% of retail price (set by the artist) and the Gallery will retain a 35% commission (Art Center members commission is 70/30). All sales will be conducted through the gallery, who will collect purchase price and Georgia Sales Tax.
9. The Gallery will receive a 35% commission on any additional sales generated as a direct result of the exhibition for 30 days following the close of the exhibition.
10. For works commissioned as a direct result of the exhibit, the Gallery will receive a 10% commission.
11. Payment from sales will be made to the artist no later than 30 days of exhibit closing.
12. Work is to be picked up no later than the date listed above, unless prior arrangements made with Gallery.
13. The Gallery assumes no liability for theft, loss, fire or destruction of any kind to any and all exhibited artwork, storage crates, or other related items (displays, baskets, boxes, etc.), however, caused throughout the duration of this Agreement.
14. By signing this contract, the artist acknowledges an understanding and agreement with the Blue Ridge Mountains Arts Association exhibition policy and requirements.
