The exhibiting artist(s) assumes all responsibility for the condition of his or her work while it is in the possession of the Center. It is strongly suggested that each artist has his/her own insurance.

The Center Gallery will receive 30% commission on the sale of all artwork during the period of exhibition, or as a result of exhibiting at the Center Gallery. Commission checks of 70% are paid to individual invitational artist(s) and are usually mailed within 30 days following the month of the artwork sale.

The exhibiting artist(s) agrees to deliver and pick up his or her artwork on the specified dates and times. The Center Gallery has no storage facilities and cannot be responsible for works left beyond the pick-up dates and times. Artists who cannot pick up their works during those specified hours must make arrangements with colleagues or friends to pick up their art work.

We can accommodate a total of 90 wall mounted pieces of art. Individual art pieces may not exceed 48" x 48". All wall art must be framed and be ready to hang. Wrapped canvases with painted and finished edges are allowed. All artwork will remain on display throughout the exhibition dates shown below. Depending upon the total number of SAAG artists who wish to participate will determine the number of pieces each artist member may submit for exhibit.

RELEASE: I understand and agree that SNCA shall not be responsible or liable for any injury, loss or damage that may arise to myself or my property while en-route, at, or departing the Center under this agreement. I release SNCA to use submitted data or photographs for publicity and to take photographs for general publicity, invitations, catalogs, etc.
